The appointment of the candidate shall be subject to the following terms and conditions :-

1. The appointee shall report to the Directorate of Information & PR, Media complex Jammu near Vishal Mega Mart, Bahu Plaza Jammu within a period of 21 days from the date of issuance of this order failing which the order shall be treated as-cancelled ab-initio.
2. The appointee shall be allowed to join only on production of the following certificates (in original);
 - I. All Academic qualification certificates.
 - II. Matriculation/date of birth certificate
 - III. Health certificate from the concerned Chief Medical Officer of the District.
 - IV. Permanent Resident Certificate issued by the competent authority.
 - V. Certificates from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under the self-employment scheme has been obtained by the appointee.
 - VI. Reserved Category certificate
3. The appointment of the candidate shall further be subject to the following conditions:

- i. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police, (CID), J&K or any other competent authority to whom a reference shall be made by the Director Information &PR, J&K, he shall have no right or claim for his appointment;
- ii. Genuineness of the academic qualification and PRC certificates from the concerned issuing authorities shall be verified.
4. The salary of the appointee shall be drawn and disbursed to him only when the satisfactory reports in respect of condition (i) and (ii) above are received in his favour.
5. If, on verification, the certificates produced by the appointee prove fake or forged, his appointment shall be cancelled ab-initio.
The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009. and SRO-202 of 2015 dated 30.06.2015.
The appointment of the above candidate shall be subject to the final outcome of writ petition(s) if any, pending in any court of the competent jurisdiction.


