As recommended by the Joint Director Information, ~~Jammu~~ vide letter No. INF/J-169/2019 dated 20-05-2019 & letter No.INF/J-444/2019 Dated 15.07.2019, sanction is hereby accorded to the appointment of Mr. Mukesh Singh Chib S/o Romesh Singh and Late Naresh Kumari, Ex- Senior Assistant , Cultural Unit, Jammu R/O H. No.122, Ward No. 7 R. S Pura, Tehsil R. S Pura as Class IV (Orderly) on compassionate grounds under SRO-43 read with SRO 177 of 2014 against overall vacancies of orderlies available in Jammu Division of Information Department in the pay level of SL-1(14800-47100) with immediate effect.

The appointee shall report to the Joint Director Information, Jammu within a period of 21 days from the date of issuance of this order. In case of failure within the prescribed joining period, his appointment shall be deemed to have been cancelled without serving any further notice.

The appointee shall be allowed to join only on production of the following Certificates in (original):

1. Academic qualification Certificates.
2. Matric/ Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Permanent Resident Certificate issued by the competent authority.
5. Certificates from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under the self employment scheme has been obtained by the appointee.

The appointment of the incumbent shall further be subject to the following conditions:-

- i. The appointee shall give an undertaking in the shape of an affidavit duly attested by the Chief Judicial Magistrate to the effect that in case adverse report about his character and antecedents is received from the Inspector General of

Police (CID) J&K; to whom a reference shall be made by the Joint Director Information, Jammu he shall have no right to claim his appointment as Orderly, in Information Department, and his appointment, as such, shall be deemed to have been cancelled ab-initio;

ii. Genuineness of the academic qualification Certificates from the concerned issuing authorities shall be verified.

The appointee shall be initially on probation for a period of two years. The salary of the appointee shall not be drawn and disbursed in his favour unless the satisfactory report in respect of (i) and (ii) above are received in his favour. If, on verification, the certificate produced by the appointee prove to be fake or forged, the appointment shall stand as cancelled ab-initio.
